But the focus of all of the conferences is education. Every conference covers both introductory and advanced material for students to learn about liberty at every level. During FY17, SFL held 467 events for over 17,000 attendees.

(Revenue \$) Leadership Programs - SFL's emphasis on leadership development has been the key to the organization's success over the years. SFL teaches young people entrepreneurship, event planning, volunteer management, effective writing, public speaking and other skills that they can use throughout their lives and gives them experience applying these skills in building the student movement of liberty. SFL trained over 2,600 student leaders that engage with thousands of student groups across the world during FY17.
